## **PAYMENT POLICIES:**

- All payments are required in advance of service.
- All tuition and program fees are non-refundable.
- Children enrolling in a program mid-month or mid-semester will have pro-rated tuition at the daily rate listed above with fees as applicable.
- Monthly installments will be assessed an additional \$20.00 bookkeeping fee per payment and will be due on the 20<sup>th</sup> of each month. No Bookkeeping fee is charged if paying by semester.
- Paying by semester includes the ability to credit planned absences to the next semester's billing. First Light must be notified in advance, in writing.
- Acceptable forms of payment include automatic withdrawal from a checking or savings account (no additional charge) and credit/debit cards (additional fees apply dependent on care type). First Light does not accept cash or checks.

## **OTHER FEES AND DEPOSITS:**

- Deposit: A non-refundable deposit will be required to secure a spot, which will be credited to your first bill.
- Registration: A non-refundable \$75 fee due with Enrollment Application or after any disruption in service provided.
- Monthly snack \$15 per student ages one and older. Families voted for this in 2018 as a convenience to save them the time and energy of purchasing on their own and delivering to the center.
- Non-Sufficient Funds (NSF); \$45 per occurrence.
- Late Pick Up: \$5 per minute after designated pick-up time, charged the following day.
- Adding a day(s) to your schedule outside of billing \$15.
